DEFERRED DISPOSITION INFORMATION

You may request Deferred Disposition for your citation. However, **YOU LOSE THAT RIGHT IF YOU FAIL TO PROVIDE WRITTEN NOTICE TO THE COURT ON OR BEFORE YOUR APPEARANCE DATE.** You may fax this form to (806) 756-4405.

You are NOT eligible if:

1. You are the holder of a commercial motor vehicle driver's license.
2. You are on deferred in any other county.
3. You do not hold a valid Texas Driver's License.
4. You were cited for speed & the alleged speed was 31 MPH or more over the limit.

If you are eligible and wish to request Deferred Disposition you must, on or before your appearance date, submit the following:

1. Enter a plea of Guilty or No Contest (see form below)
2. A notarized affidavit (see form below)
3. Provide proof of liability insurance to the court
4. Send the proper fee to the court -
 \$210.00 for 0-20 MPH over limit
 \$305.00 for 21-30 MPH over limit

If you are eligible and submit the above to the court on or before your appearance date you will be on probation for 90 days. You cannot receive another citation during this probation period.

DRIVER'S SAFETY COURSE INFORMATION

You may request that one (1) charge be dismissed by taking a Driver's Safety Course. However, **YOU LOSE THAT RIGHT IF YOU FAIL TO PROVIDE WRITTEN NOTICE TO THE COURT ON OR BEFORE YOUR APPEARANCE DATE.** You may fax this form to (806) 756-4405.

You are NOT eligible if:

1. You do not hold a valid Texas Driver's License.
2. You have had a Driver's Safety Course for the dismissal of a traffic charge within the last 12 months.
3. You were cited speeding & the alleged speed was 25 MPH or more over the posted limit.
4. You are the holder of a commercial motor vehicle driver's license.

If you are eligible you must, **ON OR BEFORE YOUR APPEARANCE DATE**, submit the following to the court:

1. A plea of GUILTY or NO CONTEST (see form below)
2. A notarized affidavit (see form below)
3. Proof of liability insurance
4. The proper court fee - \$128.00 (you will also be responsible for the cost of the course).

If you are eligible and submit the above to the court on or before your appearance date, you will then have ninety (90) days from the date of the affidavit to take any state approved Driver's Safety Course and have your certificate of completion turned into the Court.

RETURN THIS FORM FOR THE DRIVER'S SAFETY COURSE

I hereby enter a plea of () GUILTY () NO CONTEST, waive my right to trial and request the right to take a Driver's Safety Course Approved by the State of Texas.

AFFIDAVIT
