 ORDER APPROVING THE COUNTY TREASURER'S MONTHLY REPORT

At a regular meeting of the Commissioners' Court of Borden County, Texas, held on the **January 14, 2020** on a motion made by Commissioner STANSELL and seconded by Commissioner ADCOCK, the following order was adopted:
