 ORDER APPROVING THE COUNTY TREASURER'S MONTHLY REPORT

At a regular meeting of the Commissioners' Court of Borden County, Texas, held on the **August 11th, 2020** on a motion made by Commissioner STANSSELL and seconded by Commissioner REYES, the following order was adopted:

WHEREAS, Section 114.026 of the Local Government Code of the State of Texas requires that the County Treasurer provide the Commissioners' Court with a detailed financial report of the regular term of the Commissioners' Court; and


WHEREAS, the County Treasurer makes sure all books and accounts available to the Commissioners' Court for inspection and examination as they desire; and


WHEREAS, the County Treasurer has presented to the Commissioners' Court her report for the month ended **July 31, 2020**;


NOW, THEREFORE, IT IS HEREBY ORDERED by the Commissioners' Court of Borden County, Texas, that such Treasurer's Report for the month ended, **July 31, 2020**, be, and hereby is, approved and accepted as correct.


