 ORDER APPROVING THE COUNTY TREASURER'S MONTHLY REPORT

At a regular meeting of the Commissioners' Court of Borden County, Texas, held on the **February 10, 2026**, a motion made by Commissioner Adcock and seconded by Commissioner Stansell, the following order was adopted:

WHEREAS, the County Treasurer has presented to the Commissioners' Court her report for the month ended **January 2026**.
